Methodology

We conducted n=1,303 interviews online among eligible voters nationwide August 28-29

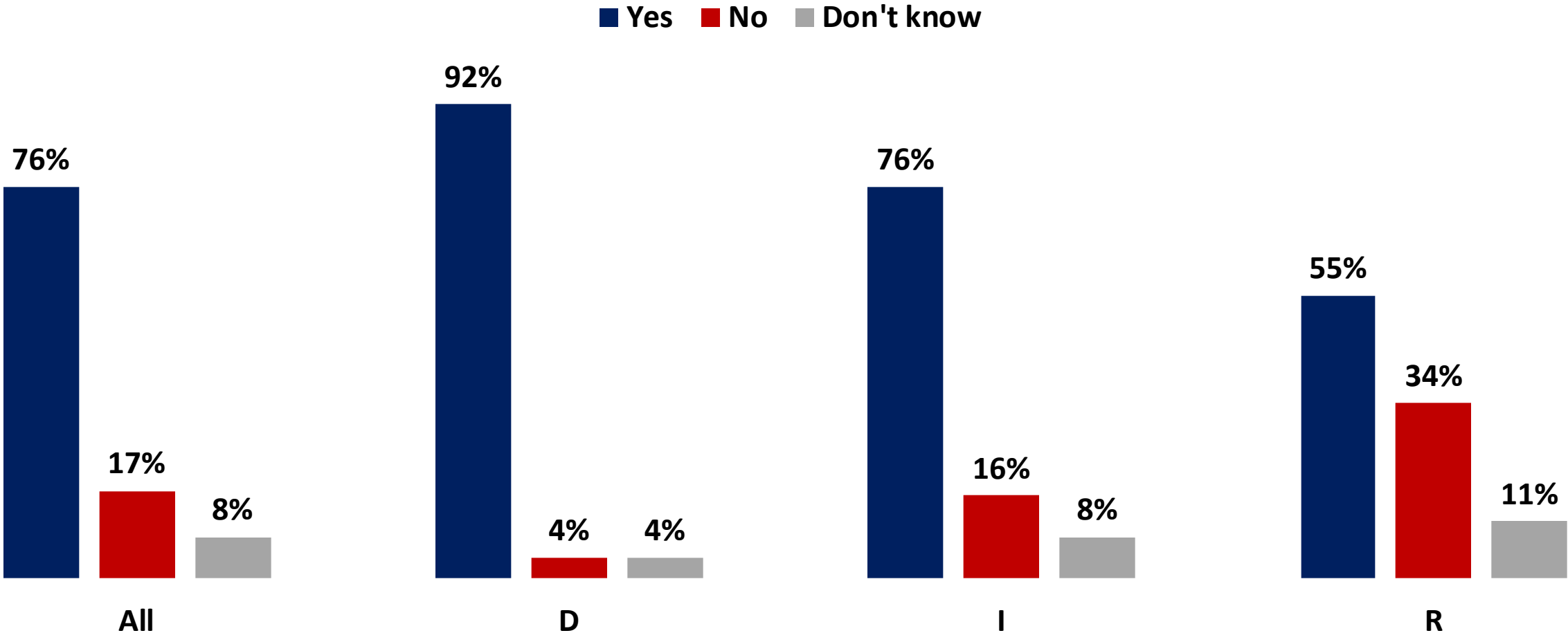
Margin of error is +/- 2.7 percentage points

Respondents are demographically representative of likely 2020 voters

- **Gender: Women 53%, Men 47%**
- **Ethnicity: White 67%, AfAm 12%, Hispanic 11%, Asian 5%, Other 5%**
- **Age: 18-29 19%, 30-44 25%, 45-60 30%, 60+ 25%**

76% Agree the Federal Government Should Implement a Plan to Transition to Clean, Renewable Energy
92% of Democrats, 76% of Independents and 55% of Republicans Agree

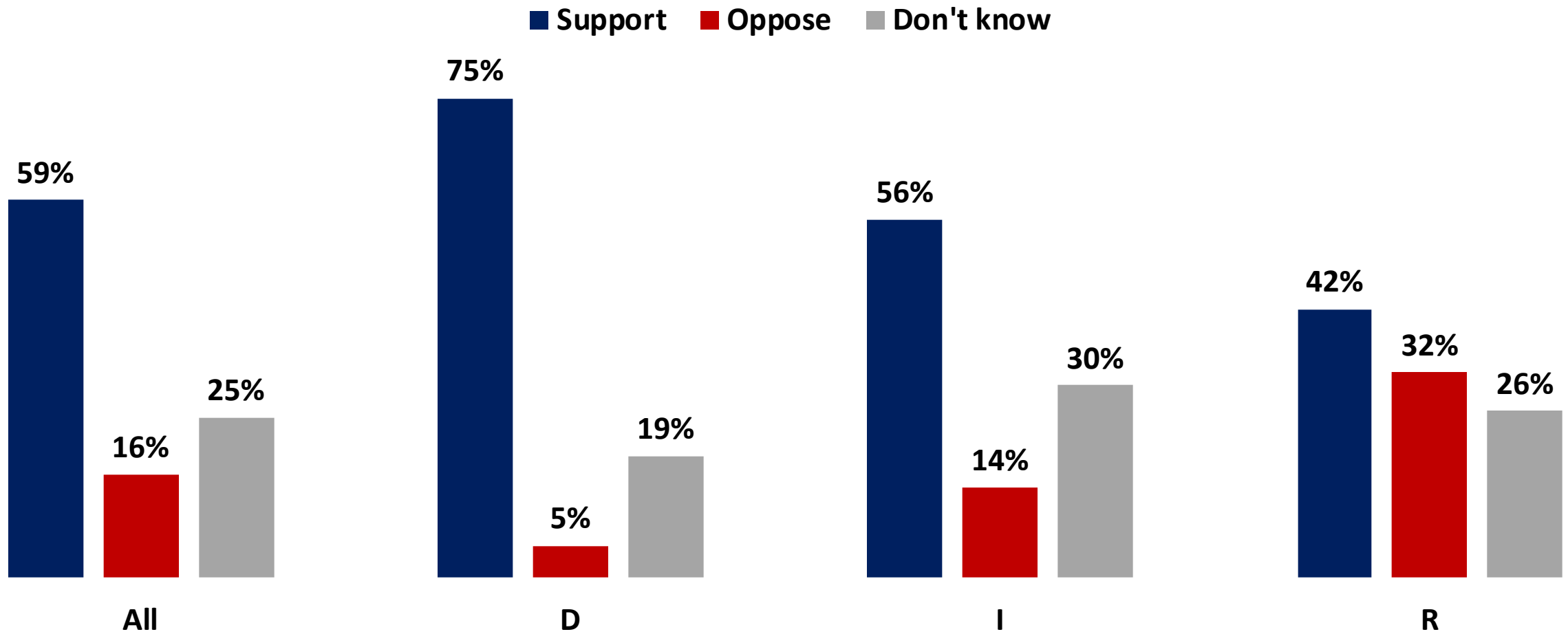
Do you agree that climate change is a significant problem in the United States and the federal government should implement a plan to transition to clean, renewable energy?



59% Support the National Climate Bank Act, Including 75% of Ds, 56% of Is and a Plurality of Rs (42%)

Only 32% of Republicans Oppose the National Climate Bank Act

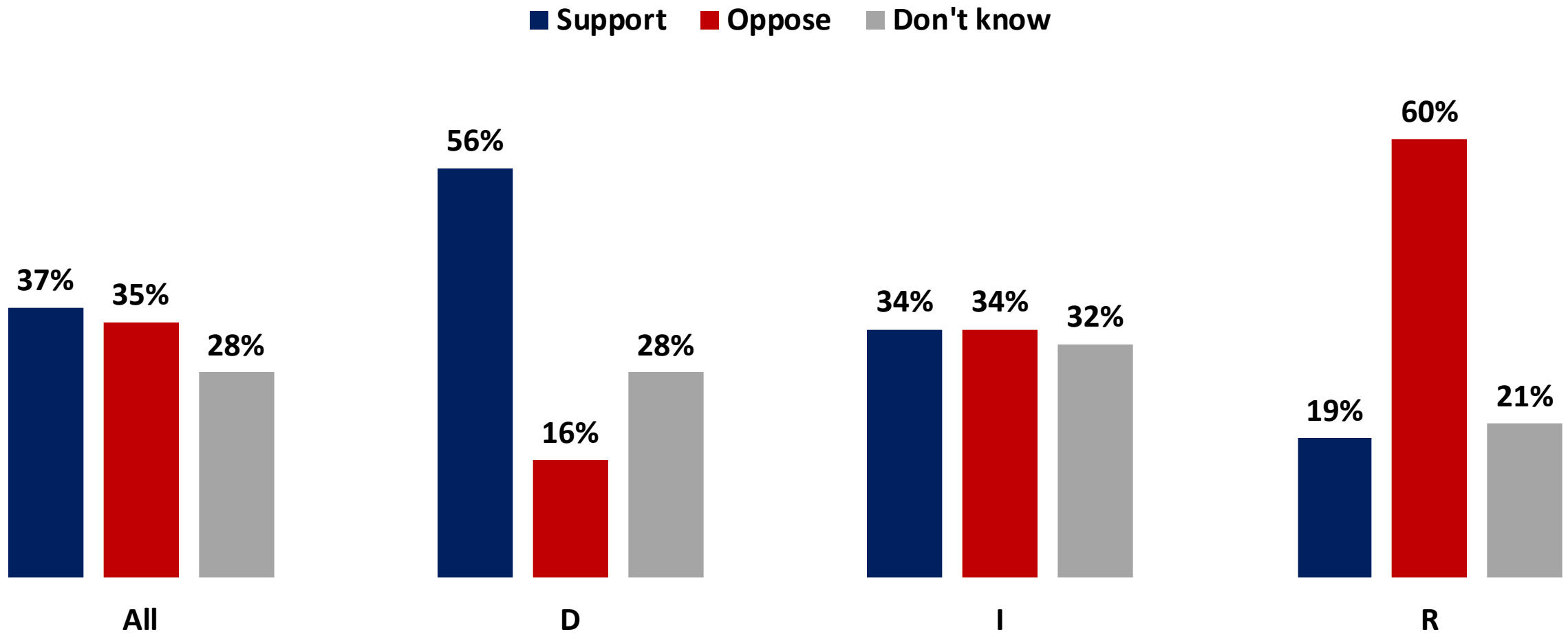
A number of senators have introduced a bill called the National Climate Bank Act. If passed into law, the federal government will contribute \$35 billion to an independent non-profit bank that combines this taxpayer money with \$1 trillion of private investment to build enough renewable power generation to meet all American electricity demand. The Act also guarantees that electricity prices will not increase as the economy moves to the clean power platform. Do you support or oppose this proposal?

Among R Voters, 60% Are Opposed

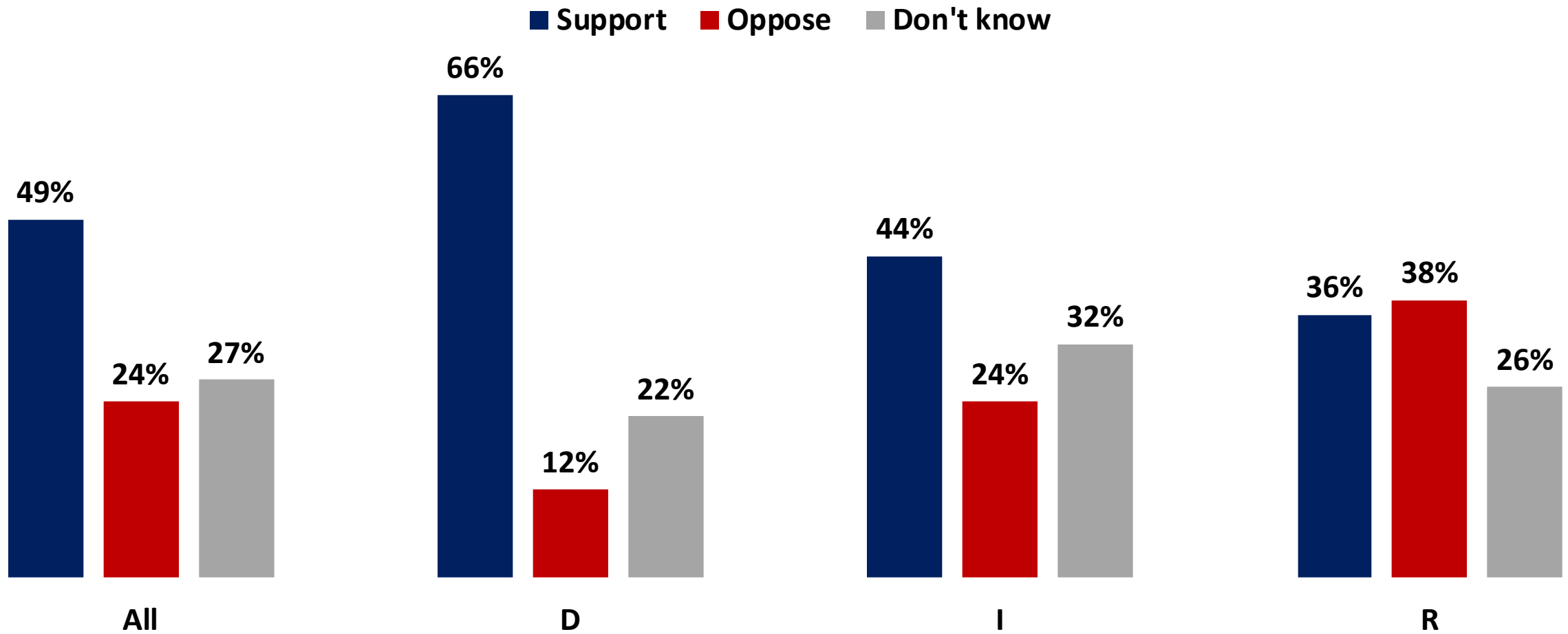

66% of Ds, 44% of Is and 36% of Rs Support Buying Coal to Keep It In the Ground

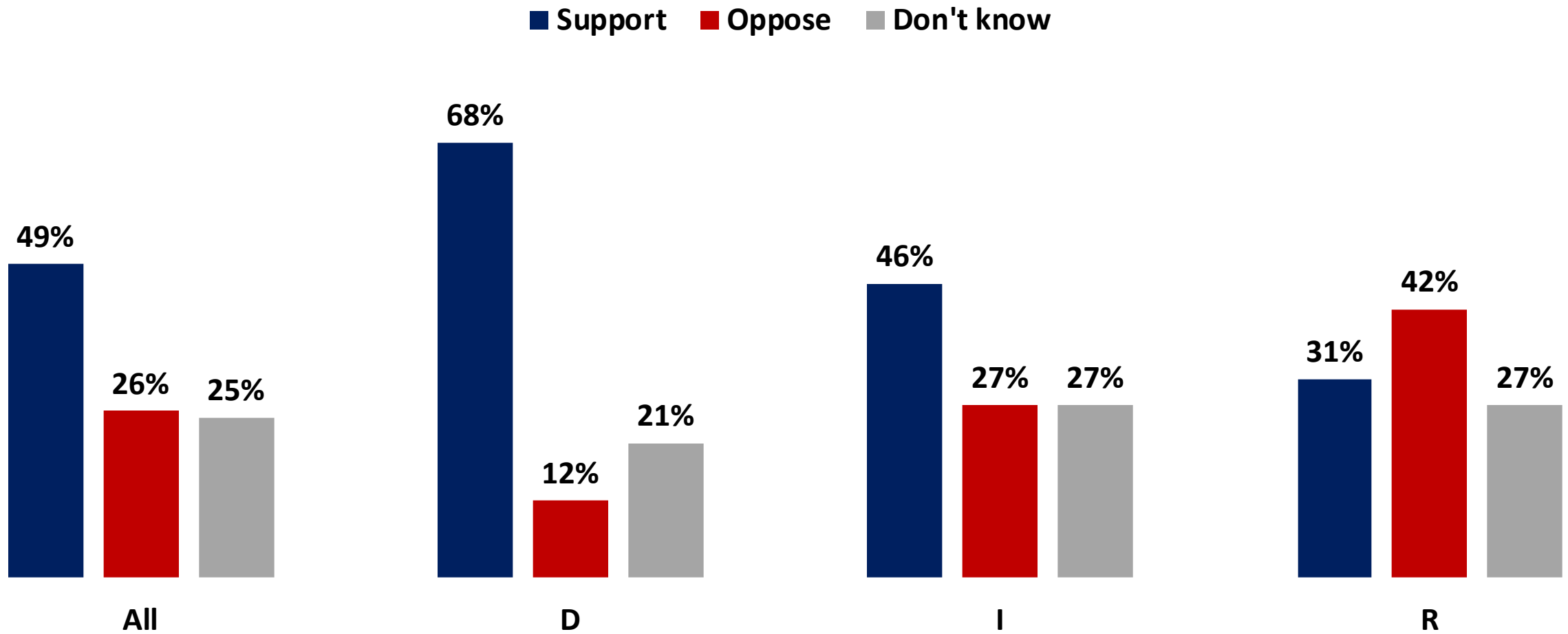

68% of Ds, 46% of Is and 31% of Rs Support Paying Coal and Gas Plants to Close

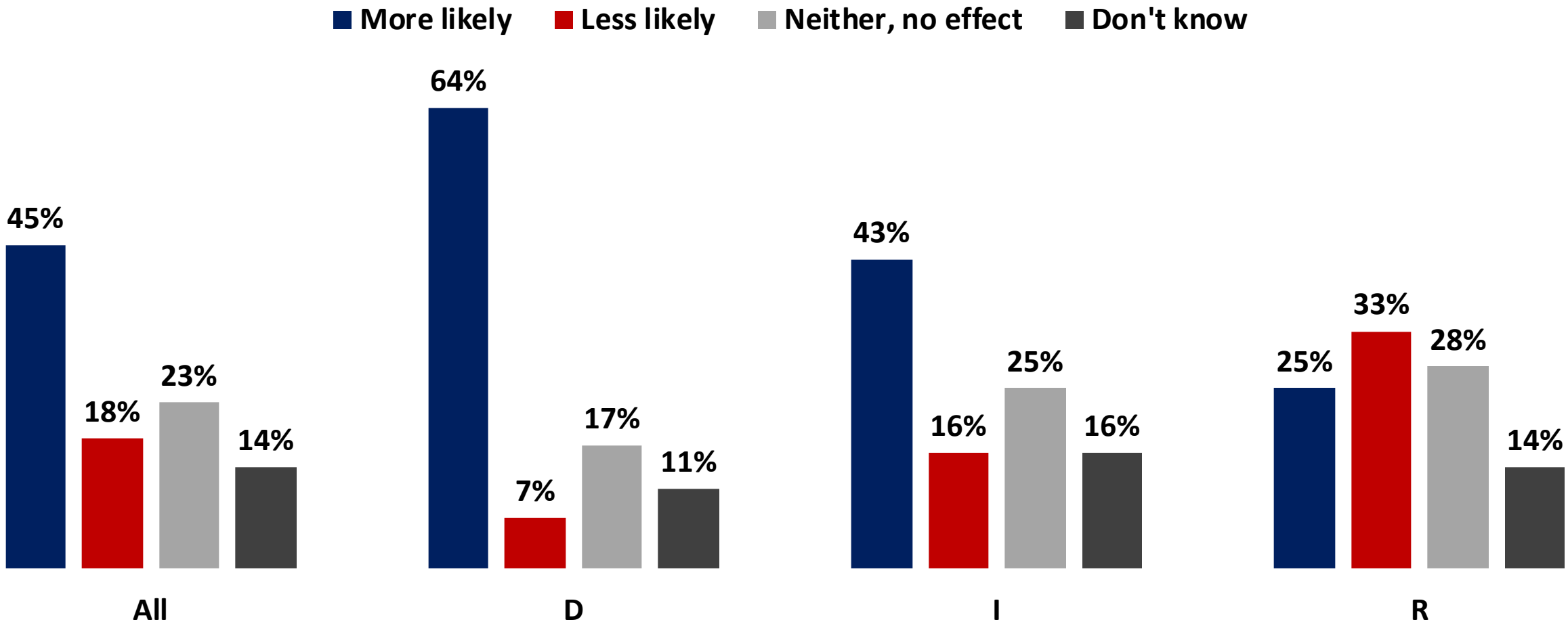
